FINDINGS & DECISION

On March 16, 2000, the Superintendent of Police filed charges with the Police Board of the City of Chicago against Police Officer John Sebeck, Star #60004, (hereinafter sometimes referred to as "Respondent") for violating the following Rules: Rule 1:

- Violation of any law or ordinance.
- Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department.
- Rule 6: Disobedience of an order or directive, whether
- Rule 8: Disrespect to or maltreatment of any person, while on
- Rule 9: Engaging in any unjustified verbal or physical altercation with any person, while on or off duty.
- Rule 14: Making a false report, whether written or oral.

The Police Board of the City of Chicago caused a hearing on these charges against Police Officer John Sebeck to be had before Michael G. Berland, Hearing Officer of the Police Board of the City of Chicago, on September 6, 2000 and September 12, 2000.

Following the hearing, the members of the Police Board read and reviewed the certified transcription of the proceedings of the hearing. Michael G. Berland, Hearing Officer, made an oral report

and conferred with the Police Board before it rendered a decision.

The Police Board of the City of Chicago, as a result of its investigation of the charges, finds and determines that:

- 1. The Respondent was at all times a Police Officer employed by the Department of Police of the City of Chicago as a Police Officer.
- 2. The charges were filed in writing and a Notice, stating the time, date and place, when and where a hearing of the charges was to be held, together with a copy of the original charges, was served upon the Respondent more than five (5) days prior to the hearing on the charges.
- 3. The hearing was conducted before Michael G. Berland, Hearing Officer of the Police Board of the City of Chicago, on on September 6, 2000 and September 12, 2000.
- 4. Throughout the hearing the Respondent did appear in person and was represented by counsel of his choice.
- 5. The Respondent Police Officer John Sebeck, Star#60004, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:

Rule 1: Violation of any law or ordinance.

A. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck, without legal justification, did intentionally or knowingly cause bodily harm to Wayne Lee by striking Wayne Lee on or about the face and body in violation of 720 ILCS 5/12-3(a) (Battery)

- B. On or about July 3, 1999, Officer John Sebeck committed a battery on Wayne Lee while Wayne Lee and/or John Sebeck was (were) located on or about a public way or public property, i.e., at or about 5800 N. Lincoln Avenue, Chicago, Illinois, in violation of 720 ILCS 5/12-4(b) (8) (Aggravated Battery)
- C. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck, knowingly and without legal justification, caused bodily harm to Wayne Lee, aged 72, in violation of 720 ILCS 5/12-4(b) (10) (Aggravated Battery)
- D. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck, knowingly damaged property of Wayne Lee, i.e., a 1987 4 door Sebring motor vehicle, without Mr. Lee's consent, in violation of 720 ILCS 5/21-1-1(1)(a)(Criminal Damage To Property)
- E. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck, by force and without legal justification, entered or reached into the interior of a motor vehicle occupied by Mr. Wayne Lee with the intent to commit a felony, i.e., aggravated battery, in violation of 720 ILCS 5/12-11.1. (Vehicular Invasion)
- 6. The Respondent Police Officer John Sebeck, Star#60004, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:
- Rule 2: Any action or conduct which impedes the Department's efforts to achieve its policy and goals or brings discredit upon the Department.

- A. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck, did unjustifiedly strike Wayne Lee, age 72, on or about the face and body, thereby bringing discredit upon the Department and impeding the Department's efforts to achieve its policy and goals.
- B. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck unjustifiedly entered or reached into Mr. Lee's motor vehicle and subsequently did damage to that vehicle, thereby bringing discredit upon the Department and impeding the Department's efforts to achieve its policy and goals.
- 7. The Respondent Police Officer John Sebeck, Star#60004, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:
- Rule 6: Disobedience of an order or directive, whether written or oral.
- A. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck violated the provisions of General Order 80-18, Section 111, Paragraph D, when he used unwarranted physical force and/or verbal abuse against Wayne Lee.
- 8. The Respondent Police Officer John Sebeck, Star#60004, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:
 - Rule 8: Disrespect to or maltreatment of any person, while on or off duty.
 - A. On or about July 3, 1999, at or about 5800 N. Lincoln

Avenue, Chicago, Illinois, Officer John Sebeck did maltreat Wayne Lee by striking him about the face and body.

- 9. The Respondent Police Officer John Sebeck, Star#60004, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:
- Rule 9: Engaging in any unjustified verbal or physical altercation with any person, while on or off duty.
- A. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck engaged in an unjustified physical and/or verbal altercation with Wayne Lee.
- 10. The Respondent Police Officer John Sebeck, Star#60004, charged herein, contrary to the Rules and Regulations, is guilty of violating, to wit:
- Rule 9: Engaging in any unjustified verbal or physical altercation with any person, while on or off duty.
- A. On or about July 3, 1999, at or about 5800 N. Lincoln Avenue, Chicago, Illinois, Officer John Sebeck gave one or more false statements or reports regarding his actions and/or the circumstances regarding the traffic accident that occurred between him and Wayne Lee on July 3, 1999.

By reason of the fact that Police Officer John Sebeck, Star#60004, is guilty of violating Rules 1, 2, 6, 8, 9, and 14 it is ordered that Respondent Police Officer John Sebeck is suspended from his position as a Police Officer with the Department of Police and from the services of the City of Chicago from March 17, 2000 to and including November 30, 2000 with restoration of all rights and benefits thereafter.




