9 MR. CAPRONI: This is Max Caproni, Executive
10 Director of the Police Board.

14 MR. CAPRONI: Yes. So two attorneys, Donna
15 Dowd and Joseph Andruzzi, filed appearances on
16 this case with the Police Board. They phoned me
17 and said that because of a prior commitment they
18 are not able to be here this morning and they
19 asked that the case be continued to August 1.

20 THE HEARING OFFICER: Does the
21 Superintendent have any objection to that?

22 MS. DEVER: No, I am just going to look.

23 I am actually off that day but let me
24 see if my colleague Johanna is available



1 August 1st. So that would be fine.

2 We do have the CR file ready to produce
3 but we don't have a protective order which we
4 were going to present today, but we have no one
5 on the other side because they are medical
6 records that we will need to enter. So we will
7 discuss that with Mr. Andruzzi.

8 THE HEARING OFFICER: Okay, so we will set
9 this for August 1 at 10:00 a.m. for a status.

10 I also want to have the attorneys for
11 Sergeant Muhammad to file their discovery by
12 July 2.

13 MR. CAPRONI: Yes, and I will advise them
14 that you have set that deadline.

15 THE HEARING OFFICER: Right. And I am going
16 to ask the Superintendent to see if they can
17 comply by July 30. And then when we meet again
18 on August 1 we can find out the status of what's
19 happening, but I would like to see some movement.

20 Do you have any other issues?

21 MS. DEVER: No other issues.

22 THE HEARING OFFICER: Thank you.
