Tracy,

2014 is still a whole year. We received several hundred FOIA requests and produced thousands of documents. I find that a hand count of those documents for 2014 to be unduly burdensome under Section 3(g) of FOIA and *Shehadeh v. Madigan*, 2013 IL App (4th) 120742, 996 N.E.2d 1243 (4th Dist. 2013).

If you are interested in seeing copies of particular FOIA requests from 2014 or the responses that we made to them, I will be glad to provide them to you. But the wholesale request for an entire year of FOIA requests and responses from 2014 is unduly burdensome under Section 3(g) and *Shehadeh* and, on that legal basis, I deny your modified FOIA request.
