Monthly Report – Date: March 11, 2009
Police & Fire Committee Meeting – Monday, March 9, 2009

RE: Monthly Report as Required Under Rule #45 of the City Council Rules of Order and Procedure for March 2009: Your Police and Fire Committee held a meeting on March 9, 2009 at 11:00 a.m. in City Hall, Room 201-A, having had under consideration the following matters:

- I. A Substitute Ordinance introduced by Alderman James A. Balcer to amend Sections 2-36-180 and 2-84-500 of the Municipal Code of Chicago, increasing the penalties (\$1,000 to \$1,500 per offense), in addition to any other penalties imposed by law, for the unlawful mis-representation of a Police Officer and/or a Fire Department Official by any person, including the misuse, wear and/or counterfeit of any badge, sign, signal or device of the Chicago Police Department and/or the Chicago Fire Department without authority to do so from the board. This mis-representation would constitute a misdemeanor, punishable by incarceration in county jail for a period of up to six months. **THE ORDINANCE WAS PASSED UNANIMOUSLY BY THE COMMITTEE.**
- II. An Ordinance introduced by Alderman Daniel S. Solis authorizing the Commissioner of the Department of Fleet Management to authorize the donation of humanitarian aid in the form of two (2) refurbished, obsolete ambulances no longer used by the City of Chicago, to the city of Tejupilco Edo de Mexico. **THE ORDINANCE WAS PASSED UNANIMOUSLY BY THE COMMITTEE.**
