- I. A communication introduced by **Mayor Richard M. Daley**, requesting the appointment of Gene Saffold to a term effective immediately and expiring July 1, 2010, as a member and chairman of the ***Chicago Emergency Telephone System Board***, to fill unexpired term of Bennett Johnson III, who resigned. **THE ORDINANCE WAS PASSED UNANIMOUSLY BY THE COMMITTEE.**
- II. A communication introduced by **Mayor Richard M. Daley**, requesting the appointment of William Boyle to a term effective immediately and expiring July 1, 2013 as a member of the ***Chicago Emergency Telephone System Board***, to fill unexpired term of Kevin R. Sullivan, who resigned. **THE ORDINANCE WAS PASSED UNANIMOUSLY BY THE COMMITTEE.**

- V. An ordinance introduced by 7<sup>th</sup> Ward Alderman Sandi Jackson.
