**Police & Fire Committee Meeting**

**RE: Monthly Report as Required Under Rule #45 of the City Council Rules of Order and Procedure for December 2009:** Your Police and Fire Committee held a meeting on Tuesday, December 1, 2009 at 10:00 a.m. in City Hall, Room 201-A, having had under consideration the following matters:

- I. An ordinance introduced by **Alderman Ray Suarez, 31<sup>st</sup> Ward**, amending the Municipal Code of Chicago, sub-section 9-102-010 (c); requesting that the criteria for Removal of Automated & Red Light Traffic Camera at Intersection of Cicero & Diversey Avenues be considered by the **Chicago Police Department (CPD)**.  
**ACTION: The Matter was deferred / held by Chairman Carothers at the request of the sponsoring Alderman, subject to call from the chair.**
- II. An ordinance introduced by **Alderman Robert Fioretti, 2<sup>nd</sup> Ward**, amending the Municipal Code of Chicago, section 2-84, and proposing changes to the operations of The Chicago Police Board, in terms of (a) appointment method; (b) term-of-office; (c) compensation; (d) resignations; (e) nominations of CPD Superintendent; (f) review and approval authority over the CPD Superintendent and the CPD budget; (g) mandating posting of Police Board and CPD actions and recommendations on the Internet within two days and making them available for a period of two (2) years.  
**ACTION: The Matter was deferred / held by Chairman Carothers at the request of the sponsoring Alderman, subject to call from the chair**
